No child admitted to the school shall be detained in any class other than class 5 and 8 until the completion of his/her elementary education or not to be expelled from the school or be subject to the prevailing rules of class promotion.

- II) No child shall be subjected to physical punishment or mental torture.
- III) Every child who completes elementary education shall be awarded a certificate as prescribed under rule – 30.

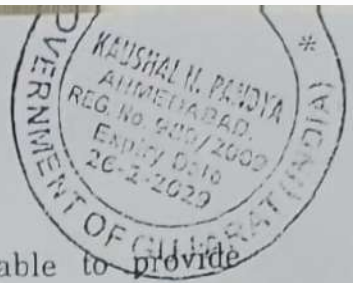
The school shall not deny admission to any child on the basis of lack of proof of age or on the basis of religion, caste, creed or gender, place of birth or any of them.

21. Measures shall be taken from time to time to ensure the safety of students and staff.
